In the midst of the traditionally busy October academic calendar and special events like Homecoming and President Olens' investiture, Kennesaw State's Office of Academic Affairs has focused a great deal of attention on filling leadership vacancies for two of our academic colleges.



Bagwell College of Education's Dean Arlinda Eaton to retire

At the end of the current academic year, Kennesaw State and the Bagwell College of Education will be saying farewell to Arlinda Eaton, who has served as dean of the college since 2008. Dean Eaton has enjoyed a long and distinguished career in elementary education and academic administration. Prior to joining KSU, she served nearly 30 years as a member of the faculty, department chair and associate dean at California State University, Northridge.

Throughout her tenure here, Dean Eaton has presided over the implementation of one of the largest grants ever awarded the University – \$8.9 million from the U.S. Department of Education to enhance K-12 teacher quality in urban schools – and the opening of a \$20 million expansion of the BCOE. She has earned distinction in the field of education, including a Bridge Impact Award from the Georgia Charter School Association, and is credited with establishing a partnership with the Marietta Center for Advanced Academics to train future STEM teachers. Her numerous contributions to Kennesaw State and its students, and to education in Georgia are deeply appreciated.
